REGULAR MEETING, MAY 17, 2022

4.04 SCHOOL BOARD APPROVES ANNUAL EDUCATIONAL EQUITY UPDATE – The 2021-2022 Lafayette School District Annual Educational Equity Update was presented for the Board's approval. The Equity Update was unanimously approved on a motion by Mrs. Marion McCray and a second by Mr. Darren Driver.

4.05 SCHOOL BOARD APPROVES EDUCATIONAL SERVICES CONTRACT – Superintendent Edwards presented the contract for educational services with Mark A. Bracewell for review. Following discussion, Mrs. Marion McCray moved to approve the proposed contract. Mr. Jeff Walker gave the second. The vote for approval was unanimous. (Contract on file in district office)

4.06 SCHOOL BOARD APPROVES PLACEMENT OF PORTABLE BUILDING- Mr. Brandon Hewett, Baseball Boosters/Coach discussed the County donating the portable building to the School District. Mr. Hewett explained

the uses for the portable building and possible location. The portable building will be placed by the baseball field and used as a clubhouse/storage for the Varsity Baseball Team. Moving, placement and set up, and any tree removal needed will be paid for by the Baseball Boosters. Mr. Hewett said they have gotten with the County's Building and Zoning Department to make sure the building will be up to code according to guidelines and restrictions. Following discussion, Mr. Jeff Walker made a motion to approve. Mr. Darren Driver gave the second. The vote for approval was unanimous.

4.07 SCHOOL BOARD APPROVES AFFILIATION AGREEMENT WITH FLORIDA GATEWAY COLLEGE- Mrs. Marion McCray moved to approve the Affiliation Agreement with Florida Gateway College, Lake City, FL. Mr. Darren Driver seconded the motion, which was unanimously approved. (Agreement on file in district office)

4.08 SCHOOL BOARD APPROVES ELL PLAN- The School Board approved the 2022-2025 District English Language Learners (ELL) Plan. This plan is approved every three years. The ELL Plan was unanimously approved after a motion by Mrs. Marion McCray and a second by Mr. Darren Driver.

4.09 SREF INSPECTION REPORTS – The 2021-2022 SREF Inspection Reports for Lafayette School District, as prepared by Fire Prevention Specialist, Inc., were presented for the School Board's review and approval. Following discussion, Mr. Darren Driver moved to approve the SREF Inspection Reports for 2021-2022. Mr. Jeff Walker gave the second which was unanimously approved.
